1. Description of both Institutions:

The College started in 1989 with the view to bring into the mainstream the girls from the weaker section, rural areas deprived of higher education. The college offers six major courses: three languages (Marathi, Hindi and English) and three social sciences (Geography, Economics and Sociology). The college has had successfully gone three cycles of NAAC accreditation and awarded Grade 'A' with CGPA 3.02 in March 2021. It is a distinctive feature of our college that it has the affiliation of SNT Women's University, Mumbai which empowers half of the population. The university is unique having no bar of affiliation across India.

AND

The organization was established in memory of great freedom fighter Late Dhanaji Nana Chaudhari, in year 1994 by Late. Hon'ble Loksevak Madhukarao Chaudhari (Ex. Speaker Maharashtra Legislative assembly). The DNCVP College was established in year 1996. The DNCVP College is NAAC Accredited 'A' grade. In year 2015-16, quality assurance committee of North Maharashtra University has accredited college with 'A' grade. In 2016 North

Maharashtra University also gives "Best College Award" to our college. The DNCVP College established with an aim to spread Social Work Education and practice in the community.

2. Objectives:

Both the institutions believe that collaborations between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities and agreed upon the following areas:

- i. To focus their efforts on co-operation within the area of research, training and extension.
- ii. To share and use of Infrastructural facilities for research and training purposes.
- iii. To jointly organize seminars, conferences, workshop etc. on various relevant and concern issues at national and international level.
- iv. To undertake the multidisciplinary research projects in Statistics and Social Sciences Departments.

3. Effective Date:

This MoU will come into effect from the date signed by both the institutions.

4. Validity:

This MoU is valid for an initial period of 5 years and may be renewed thereafter with the mutual consent of both the institutions.

5. Termination:

Both the institutions may terminate this MoU upon 30 calendar days' notice in writing. In the event of termination, both the institutions have to discharge their obligations.

1. The organization will provide training to the social work students
2. To conduct orientation meetings with social work students
3. Conduct online/offline capacity-building workshops on professional communication, PRA, Project Management etc.
4. Provide infra facilities students camps to the social work students

5. To conduct campus placement at the college and will give preference to the social work students.

Activities to be carried out by DNCVP's Loksevak Madhukarrao Chaudhari College of Social Work Jalgaon

1. To assign social work students (MSW students) for the fieldwork in respective intervention village/school/area liaised by the college.
2. To direct social work students to implement Satpuda Vikas Mandal's KVK, Pal Taluka-Yawal Dist- Jalgaon's extension program as per their guidelines
3. To appoint a nodal person for the implementation of the program at the college level (it should be a fieldwork supervisor or assistant professor)
4. To permit the social work students to attend online/offline Trainings/workshops, sessions and meetings conducted by Satpuda Vikas Mandal's KVK, Pal Taluka-Yawal Dist- Jalgaon from time to time
5. To direct social work students to attend online/offline TOTs organized by Satpuda Vikas Mandal's KVK, Pal Taluka-Yawal Dist- Jalgaon
6. Social work students will conduct stakeholder meetings with local authorities, AWW, and ASHA workers

General Provisions:

- i. Prior to the signing of this MoU, each party will bear all of its own expenses necessary to meet its duties and obligations under this MoU. Neither party can create or cause to create any charges against the other party as per this MoU.
- ii. The representatives of both the parties shall specially monitor the progress of the initiatives undertaken under this MoU.

It is hereby expressly made clear that the intention of the parties is not to create binding agreement between the parties and no part shall have right to file claim against other party. Except as expressly provided by this MoU, no Party will be liable for or bound by any representations, acts or omissions whatsoever of the other party.

Validity of the MoU Agreement: This MoU will come into effect on the date of signature by all partners and will end after 2 years from the date of signing of this agreement.

Amendment: This MoU may be varied at any time by mutual agreement of the parties in writing. It shall be reviewed one month before the end of contract date or at a time mutually agreed by the parties for possible renewal.
