15. Any Act of abuse by spoken words, emails, SMS or public insult etc.
16. Any Act of injury or infringement of the fundamental right to the human dignity.
17. Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
18. Any unlawful assembly or conspiracy to ragging.

#### **Punishment to those found guilty**

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments

5. Debarring from appearing in any sessional test / University Examination
6. Suspension from attending classes and academic privileges
7. Withdrawing scholarships and other benefits
8. Suspension from the college for a period of one month
