



Figure 2.1: Month wise energy consumption




Figure 3.1: Month wise CO2 Emission





## **3. Study of Environmental Pollution**

In this Chapter, we present the various types of Pollution as under:

## **3.1 Air Pollution**

The College is using two forms of Energies, namely: Thermal in the form of LPG and Electrical Energy used for day to day operations of the College. The major pollutant on account of above Energy forms is the Carbon Di Oxide.




Figure 2.1: CO2 emission due to usage of electrical energy.




Figure 2.1: Distribution of connected load.








Figure 3.2: Month wise electricity bill

> 1 Unit (kWh) of Electrical Energy releases **0.8 Kg of CO<sub>2</sub>** into atmosphere.

Based on the above Data we compute the  $CO_2$  emissions which are being released in to the atmosphere by the College due to its Day to Day operations




Figure 4.1: Month wise CO2 Emission

## 5. Study of utilities

#### 5.1 Study of Lighting

In the facility, the lighting system can be divided mainly in to parts, indoor lighting and outdoor lighting. There are 19 FTL fittings with Electronic/ magnetic chokes, 20 nos of CFLs, 16 nos of LED tubes, 125 nos of LED bulbs. It is recommended to install the 20 W LED Tube light fittings in place of these old T-8 fittings. There are 3 No of LED street lights.

#### 5.2 Air-conditioners

In the facility, there are about 05 Nos. of 1.5 Tr old Air-conditioners. It is recommended to replace these Old ACs with BEE STAR Rated ACs.

#### **5.3 Ceiling Fans**

At building facility, there are about 76 Nos Old Ceiling Fans, which consumed about 65 W of Electrical Energy. It is recommended to replace these old Fans with BEE STAR Rated Ceiling Fans.

#### 5.4 Water Pumps

There is no any Water pump.

# 6. Study of usage of alternate energy

In this Chapter, we compute the percentage of Usage of Alternate/Renewable Energy to Annual Energy Requirement of the College. The College has installed Roof Top Solar PV System. The Installed Capacity of Solar PV Plant is 5 **kWp**.
